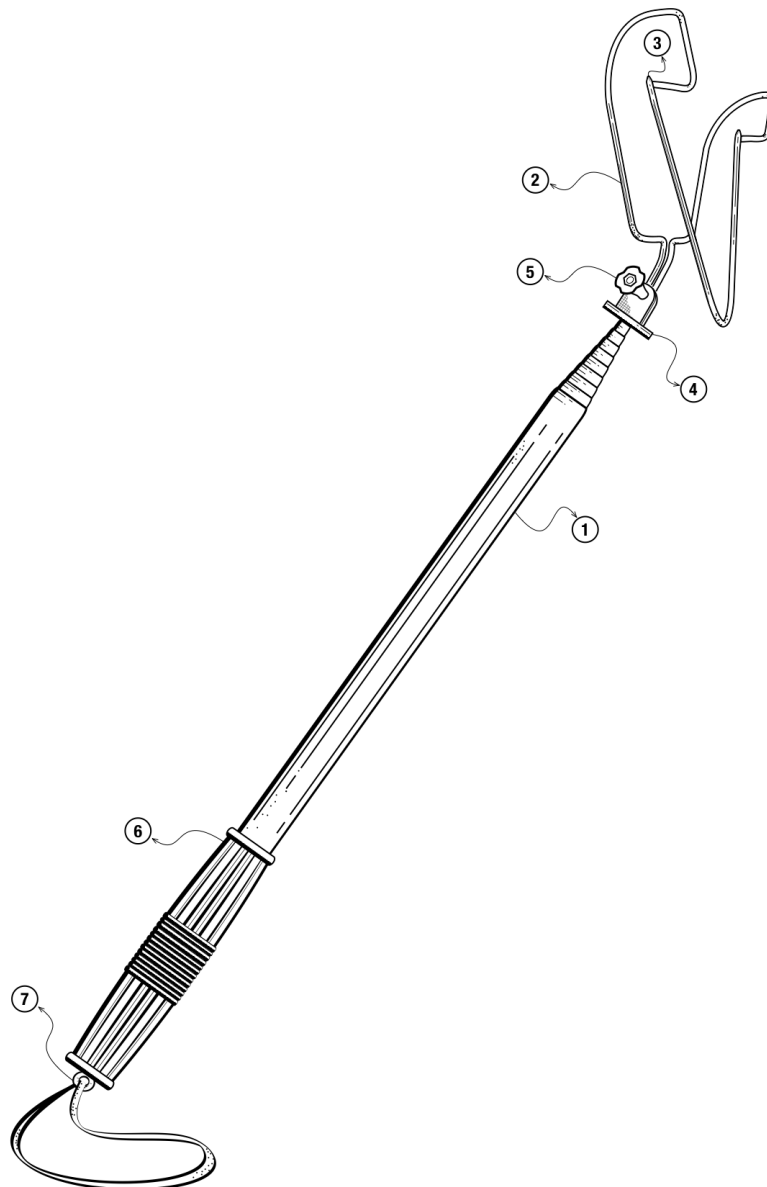

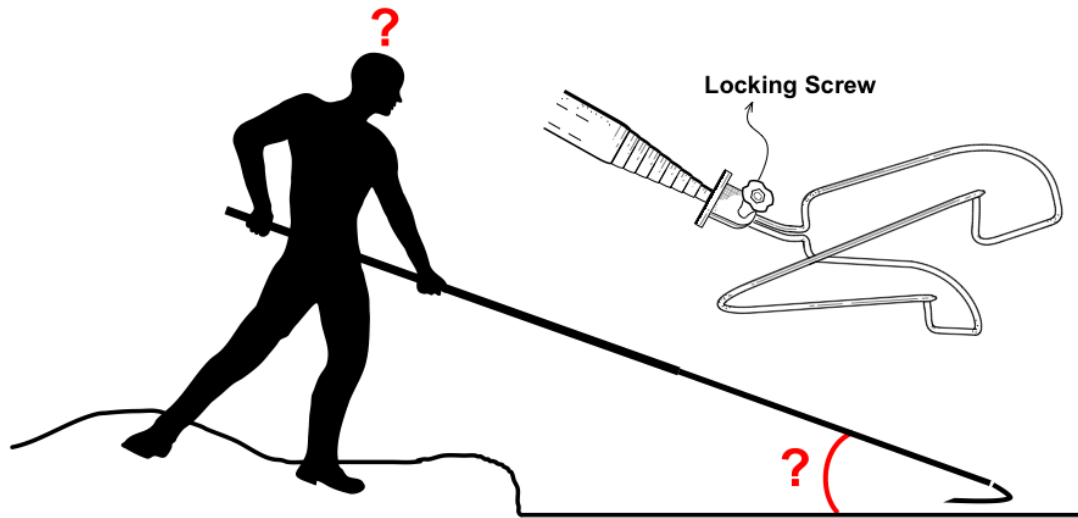

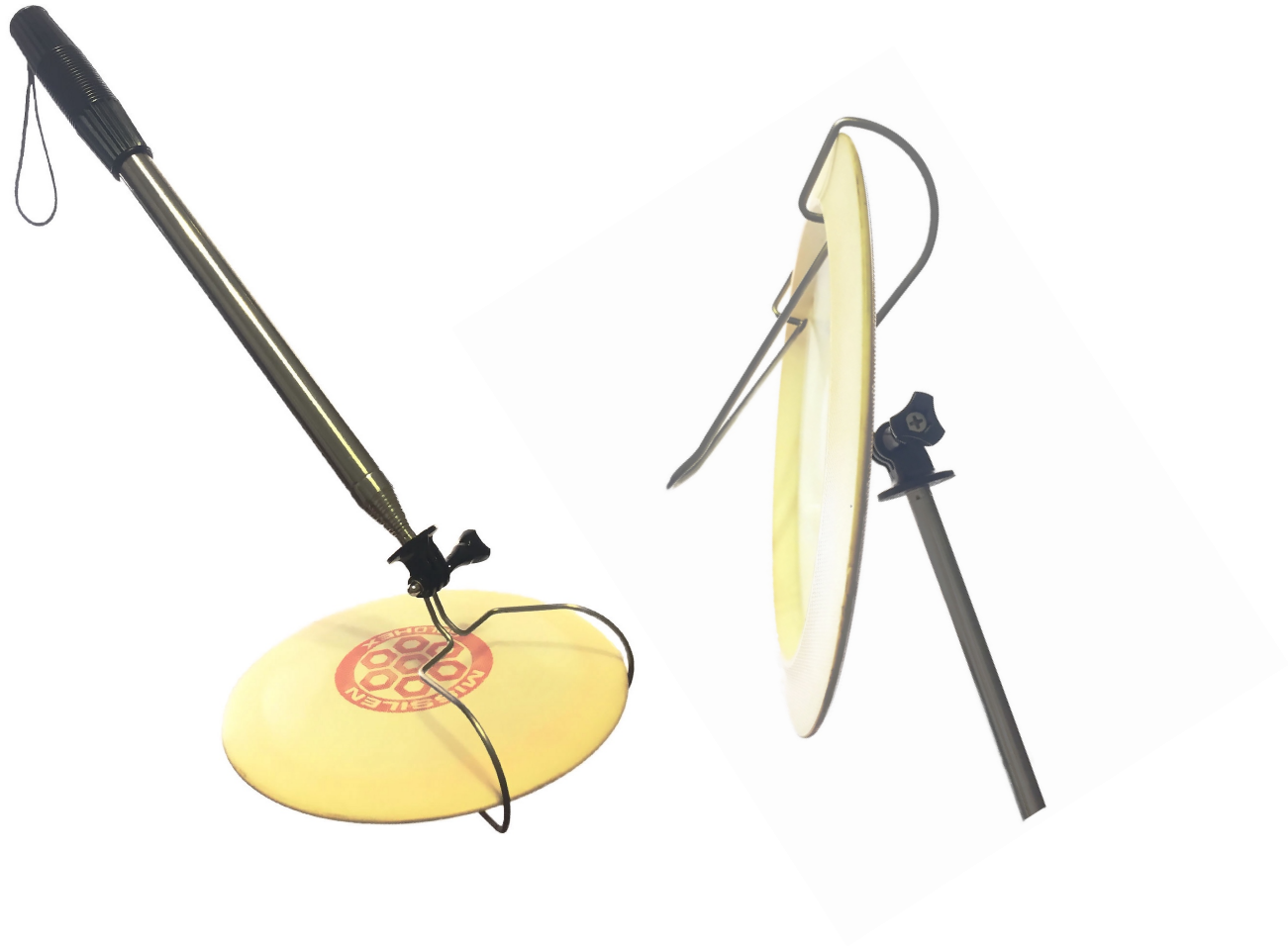

START USING THE M-RETRIEVER™



- The M-RETRIEVER has a very long pole, you will be surprised that many times you will not gonna need to extend the pole to it's entire length. Just pull out what you believe is needed for the distance that you need to reach your disc.
- After deciding on the pole length that you need, the next step is to adjust the angled of the Disc-Trap, that will make the interaction between the retriever and the disc easier and more effective. You can do that by turning the screw on the swivel mount counterclockwise until you're able to move the Disc-Trap freely but not hanging.
- To determine the angle that you need, position the Disc-Trap facing Dow flat against the ground after extended the pole and then turn the swivel screw clockwise to lock on the desired angle "without over-tightening".



- Now your Retriever is ready to work. Simply go over the disc and pull back scooping it under, until the disc slides into the Trapping-Zone.
- Bring the disc back to a safe location or just pull the pole towards you until you manually remove the disc from the Disc-Trap.



Using the M-RETRIEVER as an Action Camera Stick

The M-RETRIEVER is compatible with most action cameras in the market. Now you can capture amazing footage of your game from a whole new perspective. Simply remove the disc trap from the swivel mount and install your camera. Most cameras have WiFi wireless control via apps that allows you to view and record directly from your smart phone.

Note:

Only small light weight, *130g or less*, action cameras should be used on this setup. In any case, Magnificent Things LLC is not responsible for any losses, equipment damage or accidents. Use this feature at your own risk.

Cleaning and Maintenance

The M-RETRIEVER is composed by a multi-section stainless steel telescopic pole that is weather resistant but regular cleaning and lubrication of the sections is required to avoid material buildup inside and outside the pole. We recommend drying the pole after using on water and making sure there is no water left inside before storing the device between uses. We also highly recommend using WD-40 as cleaning and lubricant for all mobile parts.

Cautions:

Read all the instructions and warnings carefully prior to using this product.

- This product contains parts with sharp points, sharp edges, and small components that can cause injuries and present choking hazards to children.
- Do not place the product near a fire or other excessively hot environments.
- Do not try to hang or swing using the product.
- Do not try to use the product for other purposes not listed by the manufacturer.
- Do not disassemble this product or attempt to repair or modify it in any manner. (exemption to adjusting the opening distance on the Disc-Trap to better accommodation of the discs).
- Look carefully for power lines or any other electrical hazards, DO NOT try to retrieve discs from those locations. Electric shocks from live wires can be fatal.
- Do not use this product during lightning storms. The pole may work as an antenna attracting lightning directly to you causing serious injuries or possibly death.
